Which indebtness is evidenced by the Note of <u>Jerry Ware to Southern Bank and Trust Co.</u> date herewith, said principal (plus interest thereon) being payable as provided for in said Note, (the final maturity of 11/16/91after the date hereof) the terms of said Note and any agreement modifying it which is seven years are incorporated herein by reference.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS that the said Mortgagor, for and in consideration of the aforesaid indebtedness and in order to secure the payment thereof together with any renewals or extensions or modifications thereof upon the same or different terms or at the same or different rate of interest and also to secure in accordance with Section 29-3-50, as amended, Code of Laws of South Carolina (1976): (i) all future advances and readvances that may subsequently be made to Mortgagor by Mortgagee evidenced by the aforesaid Note, or by other promissory notes, and all renewals and extensions thereof; and (ii) all other indebtedness of Mortgager to Mortgagee, now or hereafter existing, whether direct or indirect, the maximum amount of all


indebtedness outstanding at any one time secured hereby not to exceed \$\frac{27,650.00}{27,650.00}\$, plus interest thereon, all charges and expenses of collection incurred by Mortgagee including court costs and reasonable attorney's fees, has granted, bargained, sold, released and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described property:

All that piece, parcel or lot of land in Greenville Township, County of Greenville, State of South Carolina, being on the West side of South Carolina Highway 253, formerly known as Charleston Street, near the City of Greenville, State of South Carolina, known as Lot No. 52 on a plat of property of Victor-Monaghan Company Developement No. 1 made by Dalton & Neves, Engineers, December 1941, recorded in the RMC Office of Greenville County in Plat Book "M", at page 39; and more particularly shown on the plat made by Carolina Surveying Co., October 30, 1984, recorded in the RMC Office of Greenville County simultaneous herewith and having according to said plat the following mets and bounds, to wit:

BEGINNING at an iron pin on the West side of South Carolina Highway 253, formally known as Charleston Street, 460 feet more or less from the intersection of South Carolina Highway 253 and Parker Road, at the joint front corners of Lots No. 51 and 52, and running thence along the common line of said lots, North 49-10 West 178.1 feet to an iron pin, joint rear corner of said lots; thence North 74-00 East 344.2 feet to an iron pin on the West side of South Carolina Highway 253, formerly known as Charleston Street; thence South 42-52 West, with the West side of South Carolina Highway 253, formerly known as Charleston Street, to the point of beginning.

The within conveyance is subject to all restrictions, setback lines, zoning ordinances, utility easements and rights of way affecting the above described property.
