Section 10.10. Amendments, Changes and Modifications. Section 10.11. References to Bank. Upon the expiration or termination of the Letter of Credit and the payment in full by the Corporation to the Bank of the Corporation's obligations, liabilities and indebtedness under the Reimbursement Agreement (as defined in the Agreement) then any provision of this Agreement requiring notification to be given to the Bank, or requiring that the Bank consent to any action, shall become ineffective; provided that if thereafter any Alternate Letter of Credit (as defined in the Agreement) is delivered to and accepted by the Trustee in accordance with Section 5.5 of the Agreement all such provisions shall be automatically reinstated for all purposes hereof.
