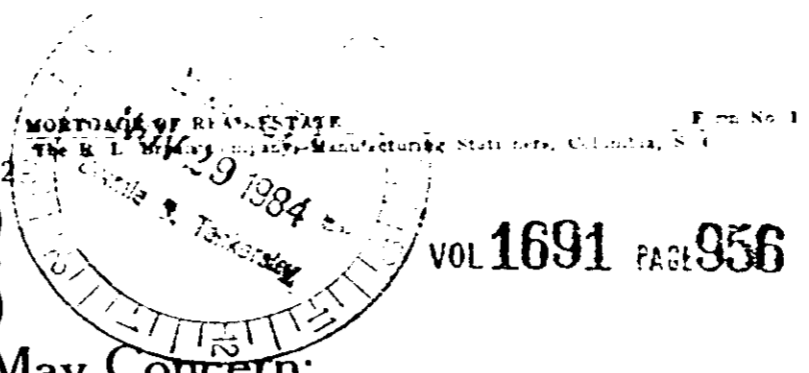

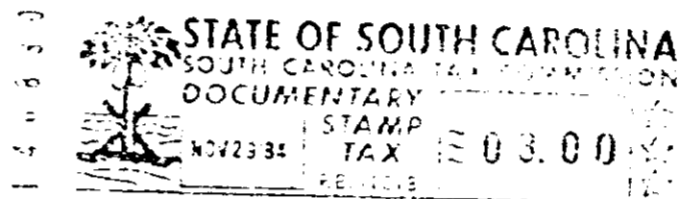

ALL that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, near the Town of Mauldin, on West Golden Strip Drive, being shown and designated as Lot No. 11, Block A on plat of Property of Mrs. B.E. Greer, recorded in the RMC Office for Greenville County, South Carolina in Plat Book MM, Page 176, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeasterly side of West Golden Strip Drive, joint front corner of Lots Nos. 11 and 12 and running thence with the joint line of said lots, S 30-00 E 364.4 feet; thence S 36-10 W 109.3 feet to a point at joint rear corner of Lots No. 10 and 11; thence with the joint lines of said lots, N 30-00 W 408.6 feet to an iron pin on the southeasterly side of West Golden Strip Drive; thence with the southeasterly side of said Drive, N 60-00 E 100 feet to the point of beginning.

This conveyance is made subject to any restrictions, reservations, zoning ordinances, rights of way and easements that may appear of record, on the recorded plat(s) or on the premises.
