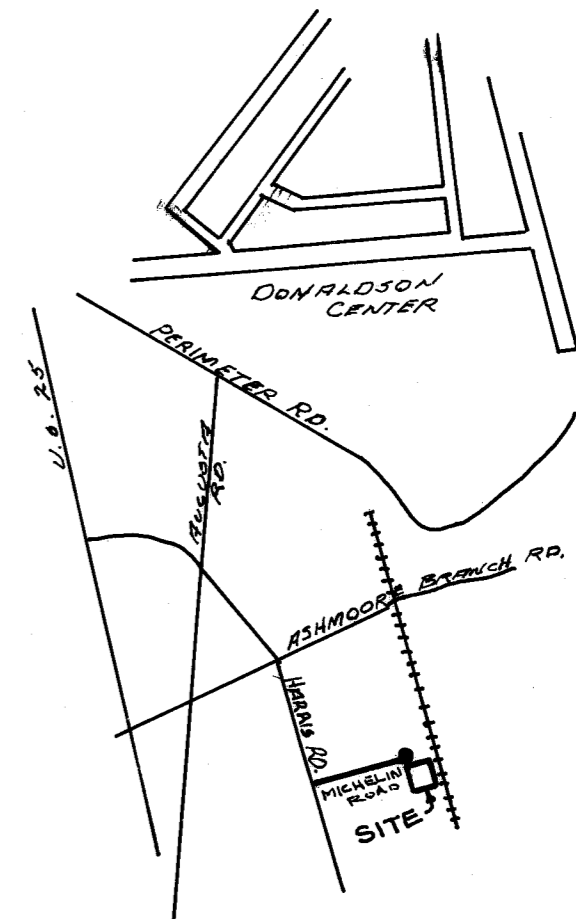
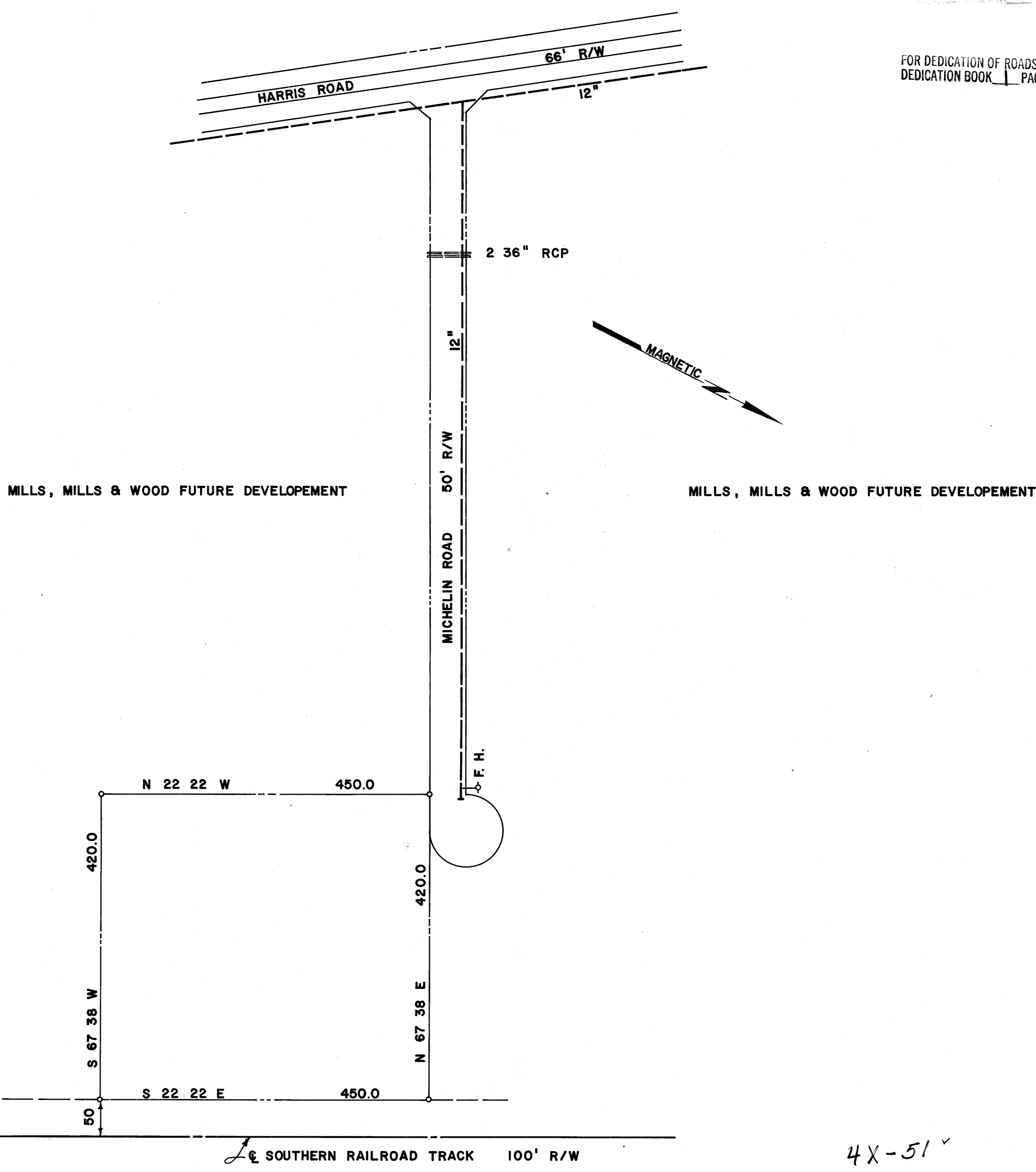

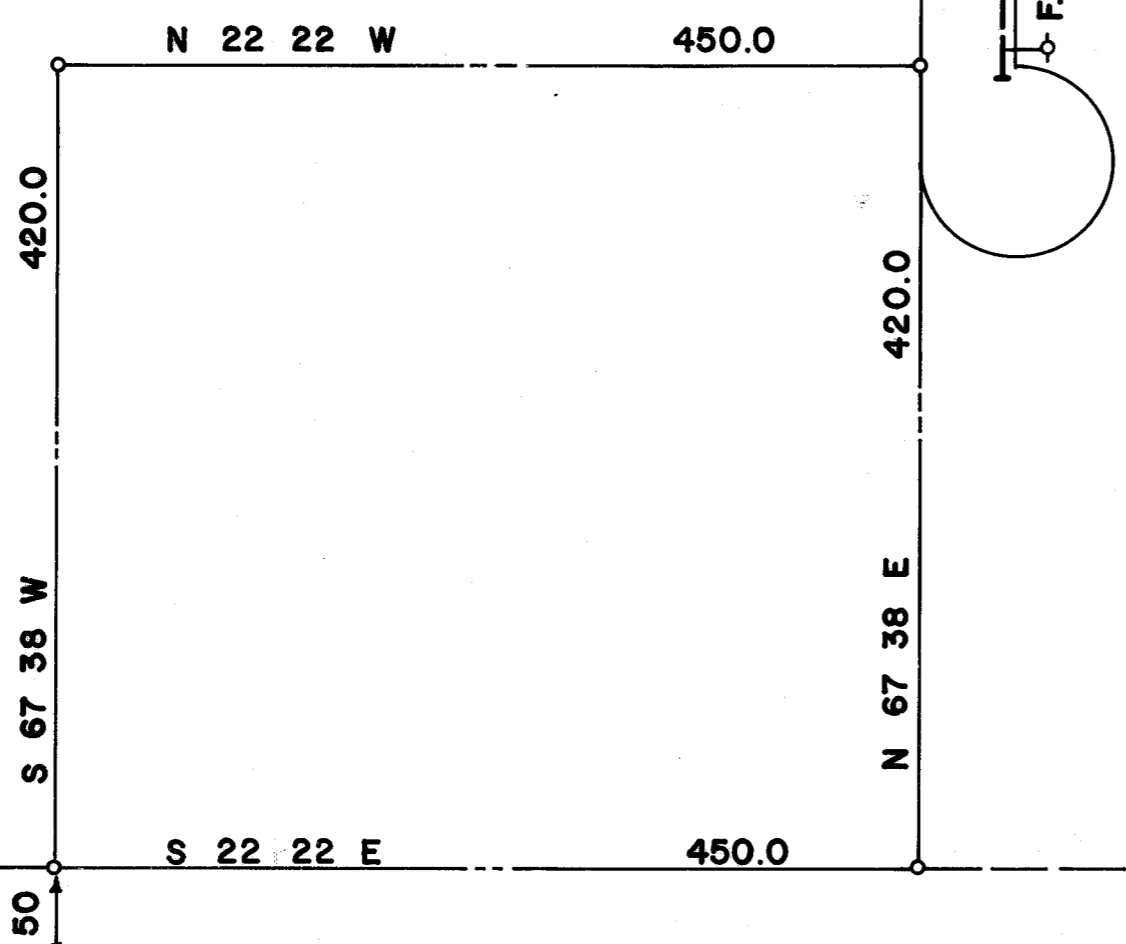


VICINITY MAP

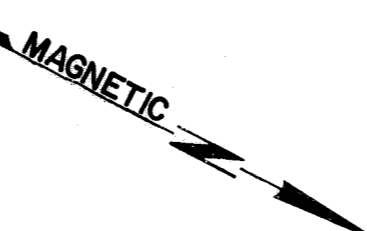

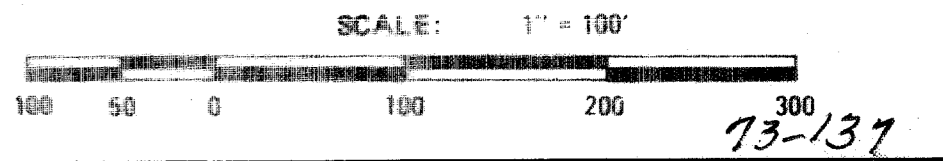
