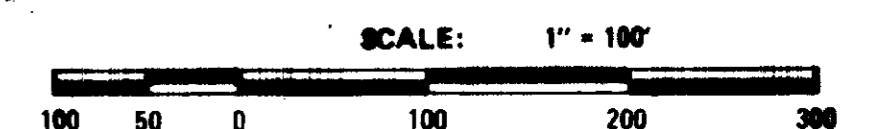

HOLLY TREE PLANTATION PHASE II — SECTION III

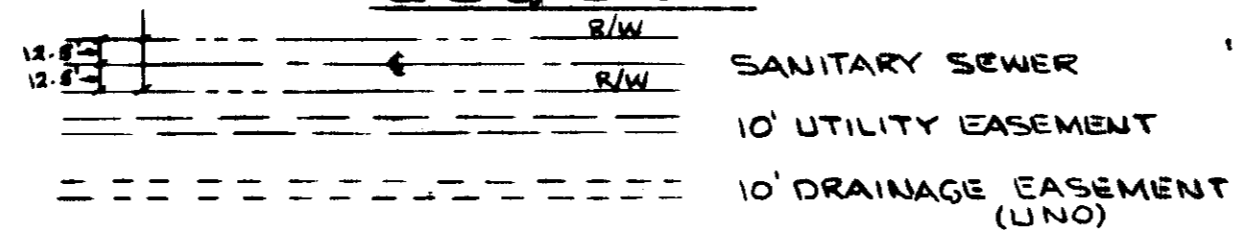
