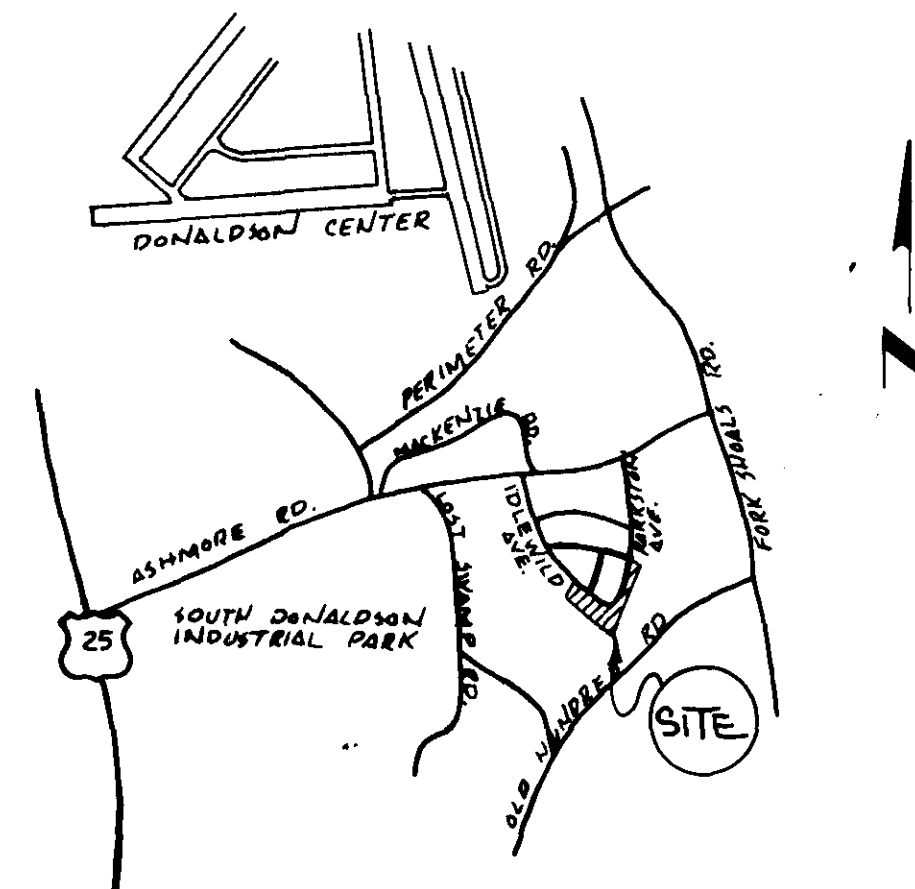

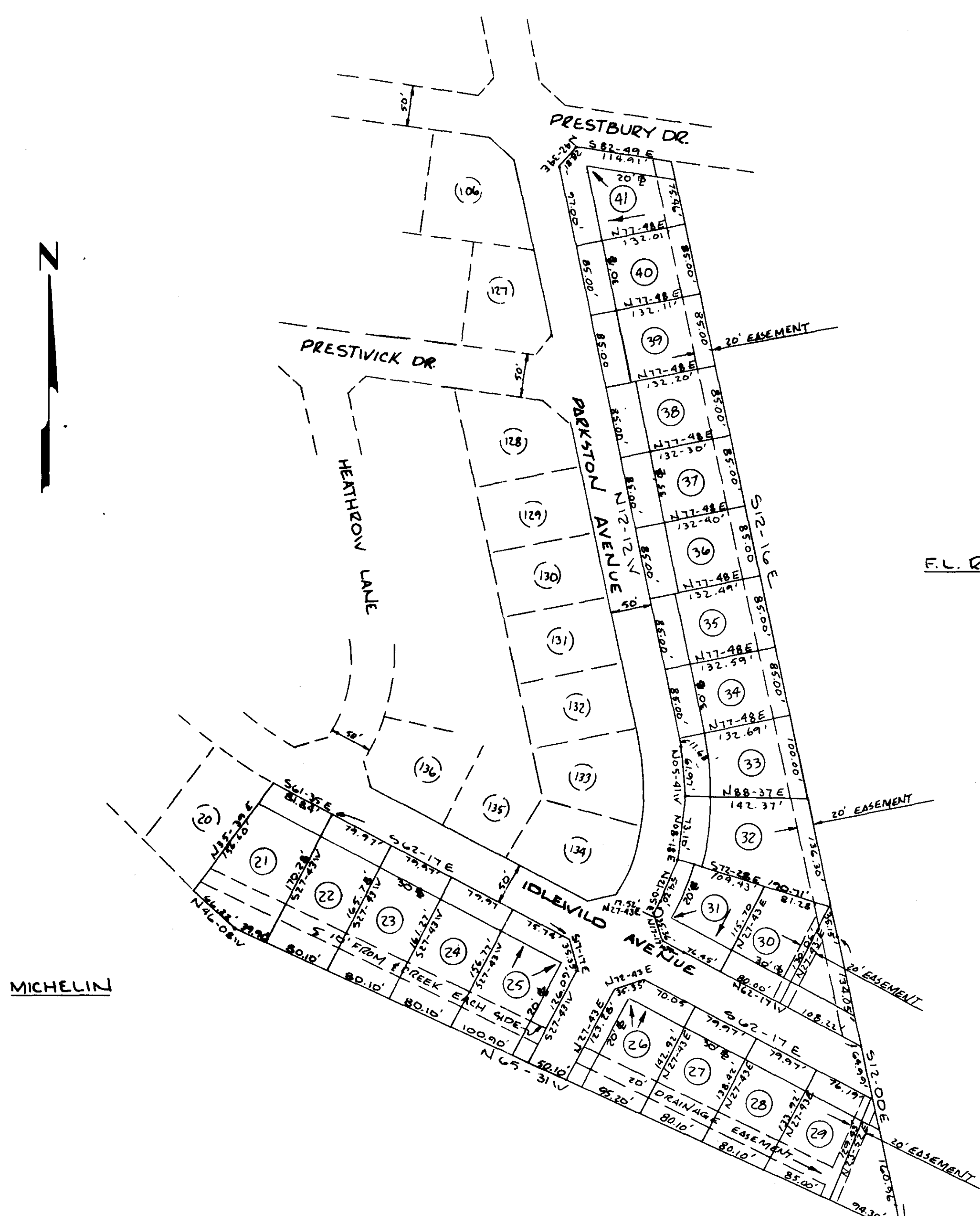
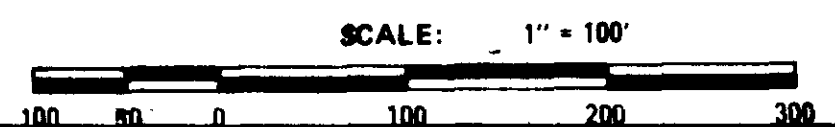

REMAINING THE SAME.

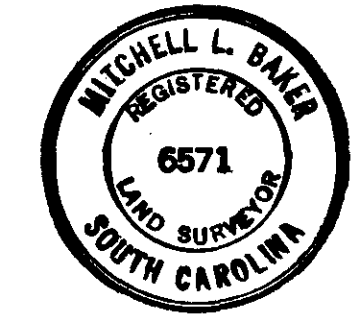
