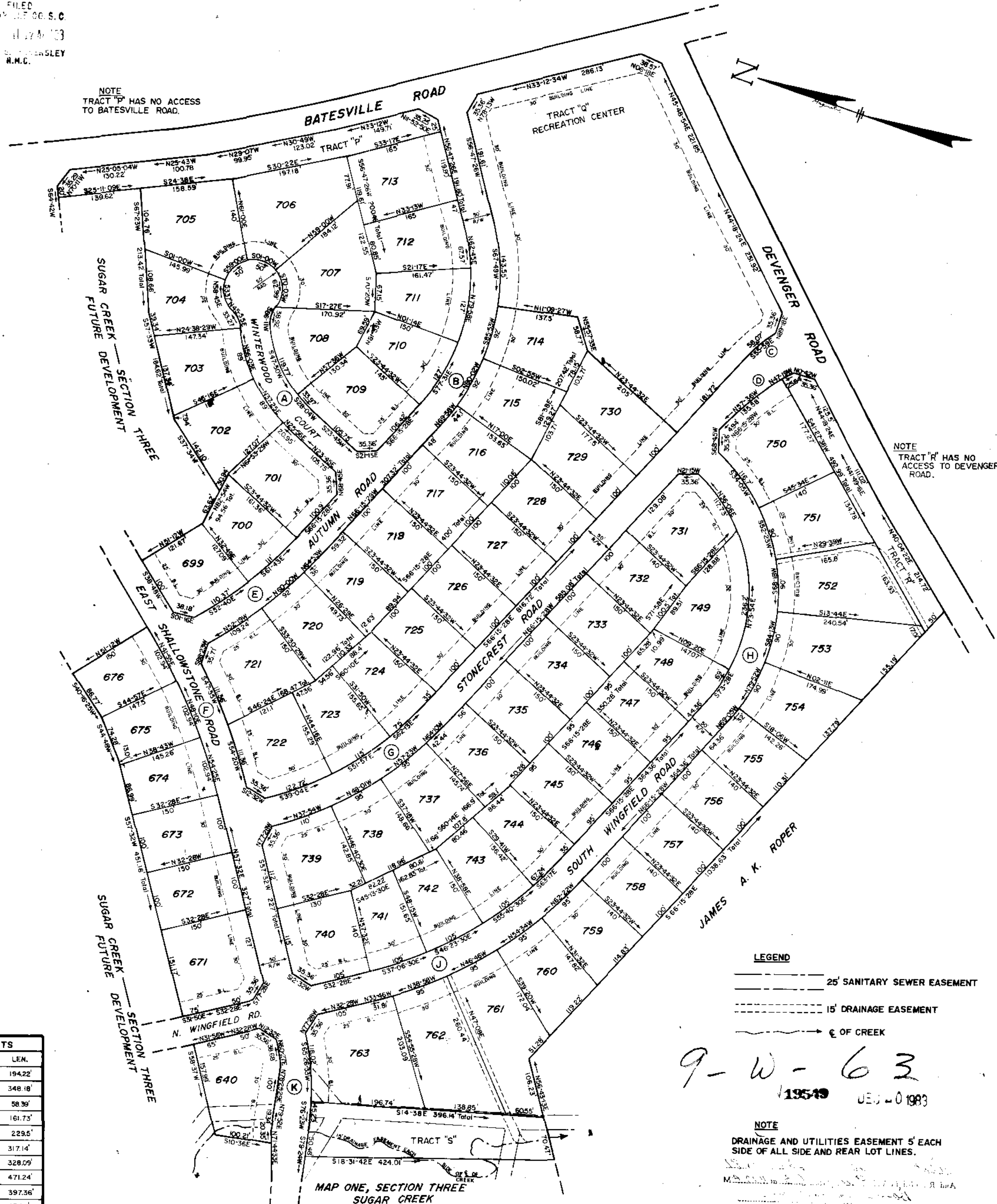

TO BATESVILLE ROAD.

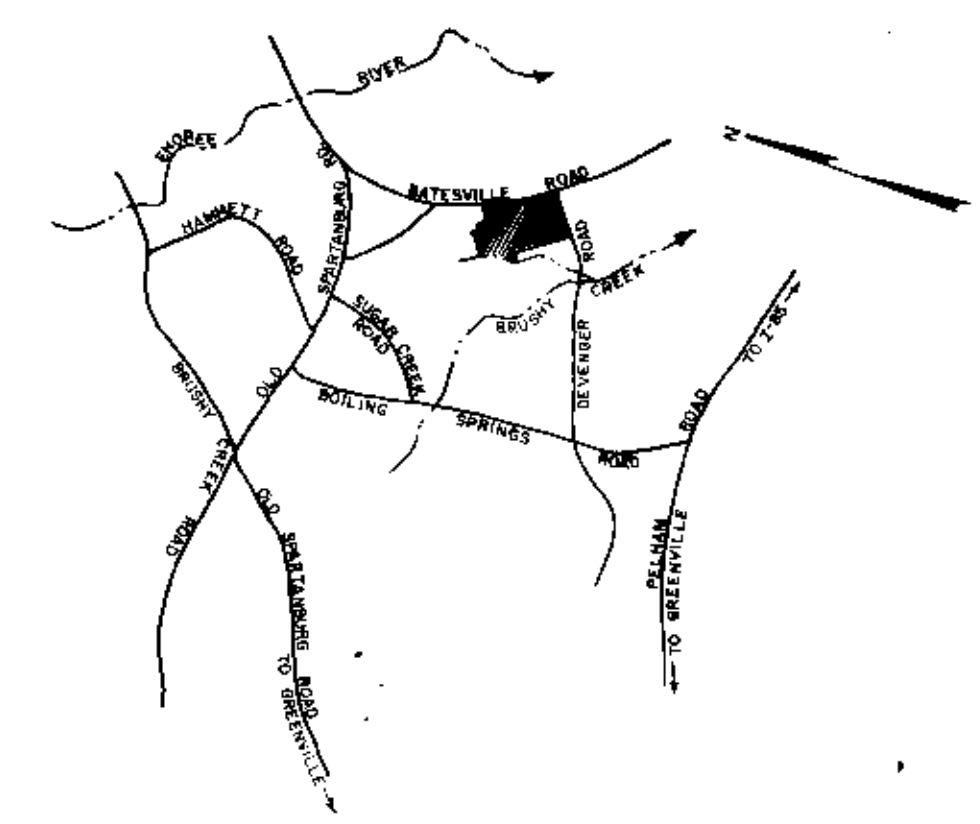

Sugar Creek

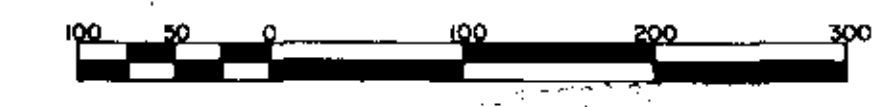
