

11.80 chains to a black gum 3x; thence N. 33 E. 4.30 chains to a pin 3x; thence N. 58 E. 16.50 chains to a white oak 3x; thence N. 12 W. 8.50 chains to a stone 3x; thence across the road again, N. 52 W. 2.50 chains to a stake; thence with the road in a northerly direction 1.58 chains to the beginning corner.

Tract No. 2, containing 6 1/4 acres, more or less, described as follows: Beginning at a stake on the creek and running thence S. 60 W. 6.70 chains to a stake on the road side; thence with the edge of the bottom, parallel with the road, to a bend in said road; thence continuing with said road, in a westerly direction, and crossing the road to a stake on the creek bank; thence down the creek to the beginning corner.
