WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Three Thousand Nine Hundred and no/100-----DOLLARS (\$3,900.00), with interest thereon at the rate of eight per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is six years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and shown as lots nos. 13 and 26 of Nickle-Town Heights on a revised plat recorded in Plat Book M at page 4 in the R.M.C. Office for Greenville County (formerly shown on plat recorded in Plat Book F at page 68) and having according to said plats the following metes and bounds, to-wit:

BEGINNING at an iron pin at the corner of Mims Avenue and Taylor Street and running thence N. 89-15 E. 220 feet to an iron pin at the corner of Taylor Street and Cook Street; thence N. 0-45 W. 40 feet to an iron pin; thence S. 89-15 W. 220 feet to an iron pin; thence S. 0-45 E. 40 feet to an iron pin, the point of beginning.

These lots are the same conveyed to the mortgagors herein by William Robinson by deed dated April 2, 1949 and recorded in Deed Book 378 at page 303 in the R.M.C. Office for Greenville County.
