All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, Butler Township, being shown as Lot 59 on plat of College Heights recorded in Plat Book P, Page 75, and having according to said plat the following metes and bounds:
