WHEREAS, the said Mortgagor(s) in and by my certain promissory note in writing, of even date with these Presents, am well and truly indebted to BANK OF GREER, GREER, S. C., hereinafter called Mortgagor, in the full and just sum of

Nine thousand - - - - - DOLLARS,

to be paid in monthly installments of \$109.20 commencing on the 15 day of December, 1969 and on the 15 day of each month thereafter until the principal and interest are fully paid, and that the final payment of principal and interest not paid sooner shall be due and payable on the 15 day of November, 1979. NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagor according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagor at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagor,

All that certain parcel or lot of land with improvements thereon situated, lying and being on the West side of Line Street in the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, designated as Lot No. 3 on a plat of the Property of J. Walter McCarter as recorded in Plat Book T, page 336, R.M.C. Office for Greenville County, and being particularly designated and shown as the Property of James Walter McCarter according to survey and plat thereof by H. S. Brockman, Registered Surveyor, dated July 31, 1951, and having a frontage of 65 feet on Line Street, a depth of 139.8 feet on the north side, a width of 104.9 feet on the rear line, and a depth of 145.3 feet on the south side.
