TO ALL WHOM THESE PRESENTS MAY CONCERN: Margaret Morris

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **Fourteen thousand eight hundred and no/100ths-----DOLLARS**

**(\$ 14,800.00** ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is **20** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the north-western corner of the intersection of West Faris Road and a 30 foot street being shown and designated as Lot 1 on Plat of Aberdeen Highlands, prepared by Dalton & Neves, in November, 1941 revised June, 1942 and recorded in Plat Book M at Page 37 and further described by an unrecorded plat prepared by R. E. Dalton, Engineer dated February 20, 1947 and being more fully described as follows:

BEGINNING at an iron pin at the northwestern corner of the intersection of West Faris Road and a 30 foot street, said street being unnamed mentioned plats and running thence along the western side of said street, N 22-15 W 177.2 feet to an iron pin on the southern side of a 20 foot alley; thence with south side of said alley, S 62-29 W 66.7 feet to an iron pin at the corner of Lot 4; thence with the line of Lot 4, S 21-06 E 167.7 feet to an iron pin on the northern side of West Faris Road; thence N 70-31 E 70 feet to the point of beginning.
