(hereinafter referred to as Mortgagor) SEND (S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of EIGHTEEN THOUSAND and no/100-----DOLLARS

(\$ 18,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southeastern side of Cope Circle, being shown and designated as Lot No. 14 on a Plat of COPE HEIGHTS, made by J. C. Hill, R. L. S., dated December 1, 1962, and recorded in the RMC Office for Greenville County, South Carolina in Plat Book III, Page 103, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at a point on the Eastern side of Cope Circle, joint corner of Lots Nos. 14 and 20, and running thence with the said Cope Circle, the following courses and distances: N. 12-35 W., 103.4 feet to a point; N. 26-00 E., 77.2 feet to a point; thence S. 64-55 E., 41.2 feet to a point, joint corner Lots Nos. 14 and 15; thence running with the common line of Lots Nos. 14 and 15 in a Southeasterly direction, 150 feet to a point in the line of Lot No. 19; thence running with the line of Lots Nos. 19 and 20 in a Southwesterly direction, 123 feet to the point and place of beginning.
