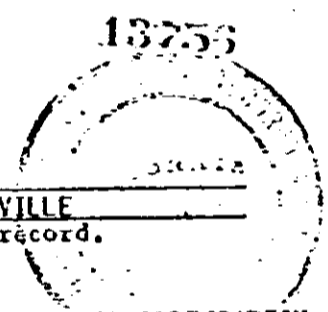
ABSTRACT OF MORTGAGE
