WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Four Thousand Two Hundred and no/100-----DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being a portion of lot 10 as shown on plat of the Property of James E. Hall Estate dated June, 1913 by Will D. Neves, engineer, recorded in the R.M.C. Office for Greenville County in Plat Book C at Page 90 and being more fully described, to-wit:

BEGINNING at an iron pin on the western side of Carter Street at a point 130 feet south of the southeastern corner of lot 9, thence S. 70-45 W. 120 feet to a pin in the line of lot 8; thence S. 0-03 W. 50 feet to an iron pin; thence N. 70-45 E. 120 feet to a pin on Carter Street; thence with the western side of Carter Street as the line N. 2 E. 50 feet to the beginning point.

This is the same property conveyed to the mortgagor by deeds recorded in Deed Book 787 at Page 561 and Deed Book 717 at Page 111 in the R.M.C. Office for Greenville County.
