TO ALL WHOM THESE PRESENTS MAY CONCERN:

JAMES A. MCGAUGHY and

FRANCES M. MCGAUGHY

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of --Forty-Three Thousand, Five Hundred and No/100-----
DOLLARS (\$ 43,500.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot NO. 77, DEVENGER PLACE, SECTION 1, as shown on plat thereof prepared by Dalton & Neves Co., Engineers, dated October, 1973, which plat is of record in the R.M.C. Office for Greenville County, S. C., in Plat Book 4-X, at Page 79, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin, joint front corners of Lots 76 and 77, and running thence with the joint line of said lots, N. 47-26 E. 150 feet to an iron pin; thence running with the rear line of said lot S. 41-25 E. 90 feet to an iron pin, joint rear of Lots 77 and 78; thence running with the joint line of said lots S. 47-49 W. 150 feet to an iron pin, Northeastern side of Longstreet Drive; thence running with the Northeastern side of Longstreet Drive N. 41-25 W. 89 feet to an iron pin, point and place of beginning.
