All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the western side of White Horse Road and being a part of Tract 10, on Map 1, of the Estate of F. M. E. Martin made by C. O. Riddle, and revised by him March 6, 1959, and having the following metes and bounds, to-wit:

BEGINNING at a point on the western side of White Horse Road, said point being 300 feet south of the B. M. Gibson property and running thence along the western side of White Horse Road S. 0-33 W. 120 feet to pin; thence N. 89-27 W. 200 feet to pin; thence N. 0-33 E. 120 feet to pin; thence S. 89-27 E. 200 feet to the beginning corner.
