WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Meyers Drive in the City of Greenville, being shown as Lot 111, Block 2, Sheet 213 of the County Block Book, and more particularly described as follows:

Beginning at an iron pin on the northeastern side of Meyers Drive at joint front corner of Lots 37 and 40 as shown on plat of G. F. Campbell Property recorded in Plat Book L at page 115, and running thence with line of Lots 37 and 38, N 40-50 E 121.4 feet to an iron pin at corner of lot now or formerly owned by H. S. Compton; thence with line of Compton lot, S 44-38 E 60.5 feet to an iron pin; thence S 39-23 W 101.7 feet to an iron pin on Meyers Drive; thence with the northeastern side of Meyers Drive, N 68-38 W 77 feet to an iron pin; thence continuing N 58-08 W 56 feet to the point of beginning.
