 (hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, and being designated as Lot No. 35 and a small portion of the rear of Lot No. 34, as shown on plat of McSwain Gardens, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book GG, page 75, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Astor Drive, joint front corner of Lot Nos. 33 and 35 and running thence on line through Lot No. 34 N. 28-20 E. 75.6 feet to an iron pin; thence S. 89-21 E. 55.45 feet to an iron pin on the easterly side of Lot No. 34; thence S. 18-03 E. 20 feet to an iron pin, joint corner of Lot Nos. 34, 35, 39 and 40; thence along the rear line of Lot Nos. 38 and 39 S. 25-41 E. 199.6 feet to an iron pin on the line of Lot No. 36; thence along the common line of Lot Nos. 35 and 36 S. 64-19 W. 108 feet to an iron pin on the easterly side of Astor Drive; thence along said drive N. 25-41 W. 199.6 feet to an iron pin, the point of beginning.
