TO ALL WHOM THESE PRESENTS MAY CONCERN: Bernice Williams

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Seven Thousand and No/100 DOLLARS (\$7,000.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid in monthly instalments of Seventy and No/100 Dollars (\$70.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township situate at the Northeastern corner of the intersection of Fairfield Drive and Lermann Drive, being shown and designated as Lot No. 2, Section 2 of Fairfield Acres as shown on plat of Property of E. W. Gregory recorded in Plat Book FF at Page 459, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Fairfield Drive at the joint front corner of Lot Nos. 1 and 2 and running thence with the line of Lot No. 2, S. 63-15 E. 168.4 feet to pin in line of Lot No. 3; thence with line of Lot No. 3, S. 2-25 W. 42.7 feet to pin in Lermann Drive; thence with the Northern side of Lermann Drive, the following courses and distances N. 87-35 W. 48 feet to pin; thence N. 75-25 W. 90.1 feet to pin; thence N. 63-15 W. 39.1 feet to pin; thence with the curve of intersection of Lermann Drive and Fairfield Drive, N. 18-15 W. 21.2 feet to pin on Fairfield Drive; thence with the Eastern side of Fairfield Drive, N. 26-44 E. 62.6 feet to pin at the corner of Lot No. 1, the point of beginning.
