All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Greenville County, South Carolina, being known and designated as Lot 32, Plat 2 of Hampshire Hills, plat of which is recorded in the RMC Office for Greenville County in Plat Book 5D at Page 79, and according to said plat, having the following metes and bounds, to-wit:
