W. Livingston, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the north side of Benjamin Avenue near the City of Greer and southward therefrom, in Chick Springs Township, being shown as Lot No. 25 of Brookhaven, Property of Dobson Estate, according to a survey and plat by H.
