All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, in the County and State aforesaid, being known and designated on a plat of "Fair Heights" as Lot No. 21 in Block I of said subdivision, and having according to said plat the following metes and bounds;

BEGINNING at a point 50 feet from the intersection of Cumberland Avenue and Hanover Street, and running thence with Cumberland Avenue 50 feet S. 31-20 W. to point; thence S. 58-40 E. 150 feet to point; thence N. 31-20 E. 50 feet to point; thence N. 58-40 W. 150 feet to the beginning corner, all of which is fully set out in the said plat which is recorded in the office of R.
