(hereinafter referred to as Mortgagor) SEND(\$) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Thousand and no/100 _____ DOLLARS

(\$30,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Seabury Drive, near the City of Greenville, being shown as Lot No. 78 on a Plat of Merrifield Park, recorded in Plat Book 000, at page 177, in the RHC Office for Greenville County, and being more fully described according to said plat as follows:

BEGINNING on the northern edge of Seabury Drive at the joint front corner of Lots 78 and 79 and running thence along a line of Lot 79, N. 19-00 E. 180 feet to a point; thence N. 71-00 W. 110 feet to a point; thence along a line of Lot 77, S. 19-00 W. 180 feet to a point on the northern edge of Seabury Drive; thence along the northern edge of Seabury Drive, S. 71-00 E. 110 feet to the beginning corner and being the same property conveyed to the Grantors herein by deed recorded in the Greenville County RHC Office in Deed Book 875, at page 66.
