(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Fifteen Thousand and 00/100----- DOLLARS

(\$ 15,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 15 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown on a plat of Johnnie & Wealthy Green, which plat is of record in the RMC Office for Greenville County in Plat Book 00-376, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of a county road running off South Carolina Highway 145; thence with the center of county road N. 3-30 W. 202.9 feet to an iron pin; thence through an iron pin at the edge of road S. 74-15 E. 322.8 feet to an iron pin; thence S. 3-30 E. 83.1 feet to an iron pin; thence S. 84-00 W. 305 feet to the beginning corner.

This being the same property devised to the Mortgagor herein by Will of Murphy N. Pitts who died testate on February 21, 1975, as will more fully appear by reference to the file of the Estate of Murphy N. Pitts found in the Office of the Greenville County Probate Court in Apartment 1372-5. This property was conveyed to Murphy N. Pitts by Deed of Lavern D. Wilford and Shirley M. Wilford, by Deed dated June 27, 1960 and recorded on June 30, 1960 in the RMC Office for Greenville County in Deed Book 653-381.
