(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ---Thirty-Five Thousand Seven Hundred and No/100--- DOLLARS

(\$ --35,700.00--), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-nine years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southerly side of Cunningham Circle (formerly Peachtree Street) near the City of Greenville, being shown and designated as Lot No. 4, Section 3, Cunningham Acres according to plat thereof prepared by C. O. Riddle, R.L.S., May 14, 1971, as recorded in Plat Book 4-N at Page 73 R.M.C. Office for Greenville County, South Carolina, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southerly side of Cunningham Circle (formerly Peachtree Street) at joint front corner of Lots Nos. 3 and 4 and thence along the joint line of the said Lots, S. 3-10 E. 165.2 feet to an iron pin; thence along the north boundary of Drexel Terrace, S. 86-53 W. 110 feet to an iron pin at joint rear corner of Lots Nos. 4 and 5; thence along the joint boundary of the said Lots, N. 3-10 W. 165.1 feet to an iron pin at joint front corner of the said Lots on the Southerly side of Cunningham Circle; thence along said Cunningham Circle, N. 86-50 E. 110 feet to an iron pin at the point of beginning.
