NEIL R. HAMMER and ANN B. HAMMER
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty Thousand Six Hundred and No/100-----DOLLARS

(\$ 40,600.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty (30) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 16 on a Plat of Stratton Place, Recorded in the RHC Office for Greenville County, South Carolina, in Plat Book 4-R at Page 36, and having, according to said Plat, the following metes and bounds:

BEGINNING at a point on the eastern edge of Providence Court, joint front corner of Lots 15 and 16, and running thence along a line of Lot 15, S. 73-08 E. 148.4 feet to a point; thence along a line of lots 13 and 12, S. 21-36 W. 227.45 feet to a point; thence along a line of Lot 17, N. 20-07 W. 210.5 feet to a point on the edge of Providence Court; thence along the curve of the edge of Providence Court, the chord of which is N. 31-35 E. 20 feet to a point; thence continuing along the curve of the edge of Providence Court, the chord of which is N. 4-38 E. 40 feet to the beginning corner.
