I, George E. Richardson, III,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto SECURITY FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Five Thousand Two Hundred and No/100----- DOLLARS (\$ --5,200.00--), with interest thereon at the rate of eight per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is ten years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the east side of E Street, in Section No. 6 of Judson Mills Village, being known and designated as Lot # 26 as shown on a plat of Section 6 of Judson Mills Village, made by Dalton & Neves, Engineers, November, 1941, which plat is recorded in the R. H. C. Office for Greenville County in Plat Book K at pages 106 and 107, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of E Street, joint front corner of Lots No. 25 and 26; and running thence with the line of lot no. 25, N. 88-23 E. 130 feet to an iron pin, corner of Lot # 106; thence with the line of lot no. 106, S. 1-37 E. 70 feet to an iron pin in the line of Lot No. 106, joint rear corner of lots 26 and 27; thence with the line of lot no. 27, S. 88-23 N. 130 feet to an iron pin on the east side of E Street; thence with the east side of E Street, N. 1-37 W. 70 feet to the beginning corner.
