TO ALL WHOM THESE PRESENTS MAY CONCERN: EDWARD A. BRIGHT AND MARIAN DALE BRIGHT

Donnie S. Tankersley (hereinafter referred to as Mortgagee) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Four Thousand Nine Hundred and No/100 (\$4,900.00) ----- DOLLARS

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that lot of land situate on the northern side of Hammett Street in the County of Greenville, State of South Carolina, being shown as Lot No. 245 on a plat of the property of F. W. Poe Manufacturing Company, Section 1, recorded in Plat Book Y at pages 26-31 inclusively, and having according to said plat the following metes and bounds, to-wit:
