WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **--Forty-Five Thousand and No/100--** DOLLARS (\$45,000.00), with interest thereon at the rate of **Five & One-Half** per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is **25** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

shown as LOT NO. 117, on a plat entitled ESTATE OF TULLY P. BABB, NEAR GREENVILLE, S. C., recorded in the R.M.C. OFFICE FOR GREENVILLE COUNTY in Plat Book QQ at Page 162, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Stonehaven Drive, at the front corner of lot No. 118; and running thence with the line of lot 118, N. 83-09 E. 466 feet to an iron pin in the T. C. Gower line; thence with the Gower line S. 12-40 E. 225 feet to an iron pin at the joint rear corner of lot 116; thence with the line of lot 116, N. 88-0 W. 484.1 feet to an iron pin on the eastern side of Stonehaven Drive; thence with the eastern side of Stonehaven Drive, N. 5-38 W. 58 feet; thence continuing with the eastern side of Stonehaven Drive, N. 13-55 W. 60 feet to pin; thence continuing still with the eastern side of Stonehaven Drive, N. 18-08 W. 32 feet to the point of beginning.
