All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Mauldin, being shown as Lot No. 18 on plat of Forrester Woods, Section I, dated March 14, 1972, prepared by R. B. Bruce, R. L. S., and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book 4N at Page 78. Reference to said plat is hereby craved for a more particular description.

BEGINNING at a point on the Southwestern side of the intersection of Cold Springs Place and Old Hickory Point and running S. 42-30 W. 132.4 feet to the joint rear corners of Lots 18 and 19; running thence N. 60-30 W. 151 feet to a point; running thence N. 25-01 E. 145 feet to the joint rear corners of Lots 17 and 18; running thence S. 72-24 E. 124.7 feet to a point on the Northwestern side of the intersection of Cold Springs Place and Old Hickory Point; thence with the curve of said intersection S. 10-21 E. 60 feet to a point on the said intersection; thence continuing with said intersection S. 69-09 E. 32 feet to the point of Beginning.
