WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

FIFTEEN THOUSAND AND NO/100 ----- DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 67, Northside Gardens as shown on plat of Northside Gardens recorded at Plat Book S, page 17, in the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Primrose Lane, the joint front corners of Lots 67 and 68 and running thence on the line of Lot 68 N 9-15 W 200 feet to an iron pin, the joint rear corner of said lots; turning and running thence S 80-45 W 90 feet to an iron pin at the joint rear corner of Lots 66 and 67; turning and running thence with the common line of said lots S 9-15 E 195.8 feet to an iron pin on the northerly side of Primrose Lane; turning and running thence with the northerly side of Primrose Lane N 88-27 W 30.4 feet to an iron pin; thence continuing with the northerly side of said Primrose Lane N 80-45 E 60 feet to an iron pin, the point of beginning.
