(hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of FOUR THOUSAND AND NO/100----- DOLLARS

(\$ 4,000.00) , as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 10 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Agnew Avenue, and being known and designated as Lots 35 and 36 on a plat of Sunny Slope, Block B, made by R. E. Dalton, May, 1919, and recorded in the RHC Office for Greenville County, South Carolina in Plat Book F, at Page 86, and having according to said plat the following metes and bounds, to-wit:

Beginning at a point at the northeastern corner of the intersection of Agnew Avenue and Santuc Avenue and running thence along the east side of Santuc Avenue N. 9-48 E. 132.8 feet to a point; thence along the line of Lot 29 S. 80-12 E. 100 feet to a point; thence along the common line of Lots 34 and 35 S. 9-48 W. 155.6 feet to a point on the northern side of Agnew Avenue; thence along the said Agnew Avenue N. 67-22 W. 51.25 feet to a point; thence still with the northern side of Agnew Avenue N. 67-22 W. 51.25 feet to the point of beginning.

This is the same property conveyed to the Mortgagor herein by deed of Jessie Mae J. Fuller and James E. Fuller recorded in the RHC Office for Greenville County, South Carolina in Deed Book 1039, at Page 566, on July 14th, 1976.
