WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty Thousand and no/100----- DOLLARS (\$40,000.00), with interest thereon at the rate of eight per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Northern side of West Seven Oaks Drive, being shown and designated as Lot 65 on a plat of Section I of Chanticleer, recorded in Plat Book YY at page 97.

BEGINNING at an iron pin on the Northern side of West Seven Oaks Drive, corner of Lot 64, and running thence with the Northern side of West Seven Oaks Drive, S. 89-27 W. 120 feet to a pin at the corner of Lot 66; thence with the line of Lot 66, N. 2-22 W. 182.7 feet to a pin in line of property now or formerly of F. H. Earle; thence with the line of said property N. 82-01 E. 31 feet to a pin; thence continuing N. 80-43 E. 96 feet to a pin at the corner of Lot 64; thence with the line of Lot 64, S. 0-41 E. 201.2 feet to the Beginning.
