TO ALL WHOM THESE PRESENTS MAY CONCERN: We, William H. Burns and Betty Jo Burns,
(hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifty-eight Hundred ----- DOLLARS (\$5800.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the south side of Westfield Avenue (formerly Maude Street) in the City of Greer, and being Lot No. 5 of the M.T. Gaines property, plat recorded in Plat Book "D", page 260, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at a point on the south side of Westfield Avenue, at the northeast corner of Lot No. 4 on said plat, and runs thence S. 17-15 E. 121 feet to point on line or corner of Lot No. 22; thence with Lot No. 22, N. 87-45 E. 60 feet to corner of Lot No. 6; thence with the line of Lot No. 6, N. 16-30 W. 132 feet to point on south side of Westfield Avenue; thence with the south side of Westfield Avenue, S. 77-15 W. 60 feet to the beginning corner.
