TO ALL WHOM THESE PRESENTS MAY CONCERN:

Calvin D. Frizzelle and Thelma C. Frizzelle
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Thousand Two Hundred and No/100----- DOLLARS

(\$ 20,200.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of the cul-de-sac of Arkrose Court in the City of Simpsonville, being shown and designated as Lot No. 485 on a plat of Westwood Section V made by Piedmont Engineers and Architects dated November 28, 1972 recorded in the RMC Office for Greenville County, S.C. in Plat Book 4-X, page 62 and lying according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Arkrose Court at the joint front corners of Lots Nos. 485 and 486 and running thence along the common line of said lots and along the line of Lot No. 487, N. 76-48 E. 179.3 feet to an iron pin; thence S. 4-39 W. 176 feet to an iron pin at the joint rear corners of Lots Nos. 484 and 485; thence along the common line of said lots, N. 62-03 W. 180.2 feet to an iron pin on Arkrose Court; thence along the eastern side of the curve of the cul-de-sac of said Court, the chord of which is N. 1-15 W. 50 feet to an iron pin, the point of beginning.

The mortgagors agree to maintain guaranty insurance in force until the loan balance reaches 75% or less of the original appraisal or sales price, whichever is less, and the mortgagee may apply for mortgage guaranty insurance to comply with the above, through the mortgage guaranty insurance company insuring this loan, and that the mortgagor agrees to pay to the mortgagee, annually, as premium for such insurance 1/4 of 1% of the
