(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Five Thousand and No/100

(\$35,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference, and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeastern side of Longstreet Drive, being known and designated as Lot No. 79 on Plat of Devenger Place, Section 1, prepared by Dalton & Neves Co., Engineers and recorded in the RMC Office for Greenville County, South Carolina in Plat Book 4X, Page 79, and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the Northeastern side of Longstreet Drive at the joint front corner of Lots 78 and 79 and running thence with the line of Lot No. 78, N. 48-12 E. 150 feet to an iron pin in the line of Lot 54; thence with the line of Lots 54 and 53, S. 41-25 E. 90 feet to an iron pin at the joint rear corner of Lots 79 and 80; thence with the line of Lot 80, S. 48-35 W. 150 feet to an iron pin on the Northeastern side of Longstreet Drive; thence with the Northeastern side of Longstreet Drive, N. 41-25 W. 89 feet to the point of beginning.
