WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Five Thousand and No/100----- DOLLARS

(\$35,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Moonville Community being known as Lot No. 12 in a subdivision of Greystone Acres, as shown on a plat prepared by Webb Surveying and Mapping Company dated December, 1967, recorded in the RMC Office for Greenville County in Plat Book TIT, at Page 17, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point in the center of Greystone Drive at the joint front corner of Lots 11 and 12 and running thence with the joint line of said lots, N. 35-08 E. 369.4 feet to an iron pin at the joint rear corner of said lots and in the side lot line of Lot 13; thence with the common line of Lots 12 and 13, N. 78-35 W. 348 feet to a point in Greystone Drive; thence with the center of said Drive, the following courses and distances: S. 30-59 W. 150 feet, S. 9-34 W. 90 feet, S. 52-58 E. 100 feet, and S. 57-45 E. 175 feet to the point of beginning.
