WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Two Thousand and 00/100

(\$ 22,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

In the City of Greenville, at the Northwest corner of Prentiss Avenue and Elm Street, being shown as Lot 4, Block D, on plat of property of O. P. Mills, recorded in Plat Book C at page 176, and described as follows:
BEGINNING at an iron pin at the Northwest corner of Prentiss Avenue and Elm Street, and running thence with Elm Street, N. 44-33 W. 135 feet to an iron pin at corner Lot 3; thence with rear line of Lot 3, N. 45-27 E. 89 feet to iron pin at corner of Lot 5; thence with the line of Lot 5, S. 45-27 W. 89 feet to the point of beginning.
