All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the city of Greenville, on the southeast side of Hialeah Road, being shown as Lot No. 363 on plat of Section B-1 of Gower Estates, made by R. K. Campbell, Surveyor, April 12, 1962, recorded in the RMC Office for Greenville County, South Carolina, in plat book XX page 107, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southeast side of Hialeah Road at the joint front corner of Lots 362 and 363, and runs thence along the line of Lot 362 S. 45-32 E. 175 feet to an iron pin; thence S. 54-10 W. 134 feet to an iron pin; thence with the line of Lot 364, N. 32-31 W. 168.7 feet to an iron pin; thence with the curve of Hialeah Road (the chord being N. 50-36 E. 95 feet) to the beginning corner.
