TO ALL WHOM THESE PRESENTS MAY CONCERN: P & W CONSTRUCTION, INC.
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-three Thousand Two Hundred and No/100 DOLLARS

(\$ 23,200.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeasterly side of Circle Drive, near the City of Greer, S. C., being designated as Lot No. 10 on plat entitled "Property of John H. Greer" recorded in the REC Office for Greenville County, S. C., in Plat Book FF, page 532 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Circle Drive, joint front corner of Lots 10 and 11 and running thence along said Drive N 47-15 E 100 feet to an iron pin, joint front corner of Lots 9 and 10; thence along the common line of said lots in a southeasterly direction 176 feet to an iron pin, joint rear corner of Lots 2, 3, 9 and 10; thence along the common line of Lots 10 and 2 S 47-15 W 100 feet to an iron pin, joint rear corner of Lots 1, 2, 10 and 11; thence along the common line of Lots 10 and 11 in a northwesterly direction 176 feet to an iron pin on the southeasterly side of Circle Drive, the point of beginning.
