C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith the terms of which are incorporated herein by reference, in the sum of Twenty-Nine Thousand Two Hundred Fifty and No/100

DOLLARS (\$ 29,250.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

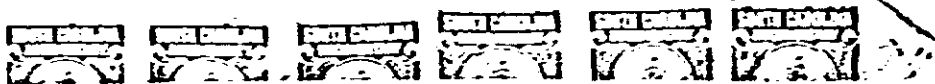

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Mauldin, shown as Lot No. 131, on plat of Holly Springs, Section II, which plat is recorded in the R.F.C. Office for Greenville County in Plat Book 4R, at Page 54, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Butler Road at the joint front corner of Lots 131 and 132 and running thence S 53-48 E 175.0 feet to an iron pin; thence N 32-10 E 121.3 feet to an iron pin; thence N 60-43 W 175 feet to an iron pin on the eastern side of Butler Road; thence with said Butler Road S 3-59 W 100 feet to an iron pin, being the point of beginning.
