WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty Thousand Three Hundred Fifty-nine and 62/100----- DOLLARS,

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of

Swindon Court,, being known and designated as Lot No. 130 on a plat of Kingsgate made by Piedmont Engineers and Architects, dated January 9, 1959 and recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 222, page 45 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Swindon Court at the joint front corners of Lots nos. 129 and 130 and running thence with the common line of said lots, N. 4-56 W. 181.4 feet to an iron pin; thence N. 58-19 E., 75.0 feet to an iron pin; thence S. 31-41 E., 145.0 feet to an iron pin; thence S. 26-21 E., 76.9 feet to an iron pin at the joint rear corner of lots nos. 130 and 132; thence along the common line of said lots, S. 59-57 W., 116.5 feet to an iron pin on the northern side of Swindon Court; thence along the curve of the northern side of Swindon Court, the chords of which are, N. 41-46 W., 35.0 feet and N. 82-57 W., 35.0 feet to an iron pin, the point of beginning.
