All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Palm Street (formerly Hall Street), Nicholtown, City of Greenville, and being known and designated as Lot No. 8 as shown on plat of subdivision made for Carrol McDaniel recorded in the R. M. C. Office for Greenville County in Plat Book "C", at Page 140 and having, according to said plat, the following metes and bounds, to-wit:
