All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the southern end of the cul de sac at the intersection of Barry Drive and Chapman Drive being shown and designated as lot 38 on plat of Terrace Gardens recorded in Plat Book QQ at page 85 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:
