"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southwest corner of Garrison Road and an unnamed street near the City of Greenville, and having, according to a plat entitled "Property of Victor E. Fienup" made by R. K. Campbell dated December 9, 1966, the following metes and bounds, to-wit:

Beginning at an iron pin near the eastern edge of Garrison Road at the corner of property now or formerly owned by Pepper and running thence N. 34-0 E. 100 feet to an iron pin near the eastern edge of Garrison Road; thence running across Garrison Road and along the southern edge of an unnamed street N. 76-35 W. 118 feet to an iron pin at the corner of property now or formerly owned by Gambrell thence with the line of Gambrell property S. 34-0 W. 100 feet to an iron pin at the line of property now or formerly owned by Pepper; thence with the line of said property S. 76-35 E. 118 feet to an iron pin;
