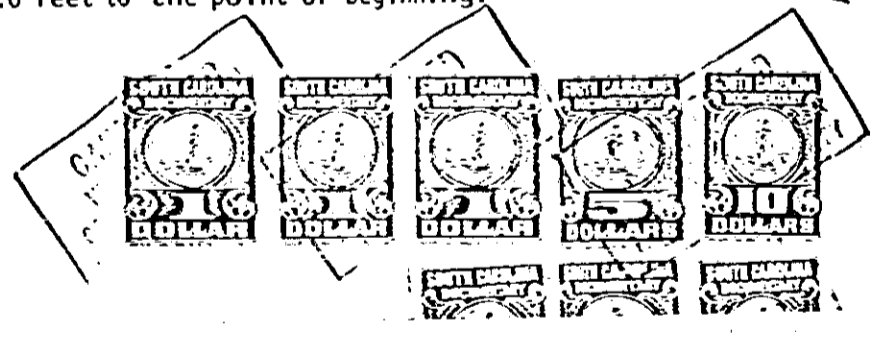

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Swindon Circle, being shown and designated as Lot 137 as shown on a plat of Sec. II, Kingsgate, prepared by Piedmont Engineers and Architects and recorded in the RMC Office for Greenville County in Plat Book 5-0, at Page 23, and having according to said plat the following metes and bounds, to-wit:

Beginning at a point on the northern side of Swindon Circle at the joint front corner of Lots 137 and 138 and running thence along the common line of said Lots N. 32-00 W. 139.5 feet to a point; thence along the rear lines of Lots 143 and 144 N. 58-15 E. 120.0 feet to a point; thence along the joint line of Lots 136 and 137 S. 32-00 E. 150.0 feet to a point on the northern side of Swindon Circle; thence along the said Swindon Circle S. 58-00 W. 120.0 feet to the point of beginning.
