All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 77 on plat of Monaghan Subdivision, Section Two recorded in Plat Book GG at page 151 in the RMC Office for Greenville County, and having the following metes and bounds:
