WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southeast side of Terrace Street, being shown as lot # 21, on plat of the property of Sam Zimmerman, Jr. recorded in Plat Book O at Page 23, and having according to said plat the following ~~said premises conveyed to the mortgagor by Sam Zimmerman, Jr. by deed recorded in Book of Deeds 463 at Page 377.~~"
