WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, located at the intersection of N. Main Street and Tremont Avenue, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northeast corner of N. Main Street and Tremont Avenue; thence along the East side of N. Main Street, N. 19-55 E. , 90 feet to an iron pin; thence S. 69-25 E. 175 feet to iron pin; thence S. 19-55 W. 90 feet to iron pin on N. side of Tremont Avenue; thence along the north side of Tremont Avenue, N. 69-25 W. 175 feet to the beginning corner.

This is the same property conveyed to the mortgagor by deed of Joseph J. Pazdan and Allie Mack Haywood Pazdan to be recorded herewith.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's account and collect it as a part of the debt secured by the mortgage.
